

## COOKIE POLICY

Our website <https://www.sipsa.ch/it/> (hereinafter: “the Website”) uses cookies and other related technologies. Cookies are also placed by third parties engaged by us. This document informs you about the use of tracking tools on our Website.

Please note that this information does not concern other websites, pages, or online services accessible through any hyperlinks that may be published on the Website, including social media pages such as Facebook, Twitter, Instagram; with regard to those, you are invited to consult the respective privacy notices.

### 1. Website User

You are the person accessing our Website to whom this notice is addressed, also referred to as the Data Subject.

### 2. Data Controller

### 4. What are cookies?

Cookies are small strings of text that websites visited by the User send to the User’s device (usually to the browser), where they are stored in order to be retransmitted to the same websites upon the User’s next visit. While browsing the Controller’s Website, the User may also receive cookies sent from different websites or web servers (“third parties”), which may contain certain elements (such as images, maps, sounds, specific links to pages of other domains) displayed on the Website being visited. Cookies, which are generally present in large numbers in Users’ browsers and sometimes persist for long periods of time, are used for various purposes: execution of computer authentication, monitoring of sessions, storage of information on specific configurations concerning Users accessing the server, etc.

### 5. Cookie

Cookies may be classified as follows:

#### 5.1. Technical or functional cookies (Strictly Necessary Cookies and Functionality).

Technical cookies are necessary for the operation of the Website and cannot be disabled in our systems, as they ensure the Website functions properly and that the User’s preferences remain valid. They are generally set only in response to actions taken by the User, such as setting privacy preferences. Functional cookies make it easier for the User to browse our Website, so that the User does not need to repeatedly enter the same information when visiting our Website; examples include login details, form completion, or retaining the contents of the shopping cart until payment is completed.

These cookies are installed without the User’s consent.

#### 5.2. Statistics cookies - Analytical Cookies (Performance Cookies).

These cookies allow us to count visits and traffic sources, so we can measure and improve the performance of our Website.

#### 5.3. Marketing/profiling cookies (Targeting Cookies).

These are marketing and tracking/profiling cookies intended to provide advertising space and/or profile Users based on their choices and interests. They may be installed by the Website Controller or by third parties, only after obtaining the User’s consent. They may be sent to the User’s browser by third-party companies, directly from their own websites, for their purposes, including profiling. They are used to track visitors across websites. The aim is to present advertisements that are relevant and engaging for the individual User, and therefore of greater value to third-party publishers and advertisers.

## 6. Cookies used on our Website

Our Website uses only technical and functional cookies, specifically:
